The Accountancy and Financial Management Association (AFMA) is the student association of the Department of Accounting which aims at the enhancement of knowledge, skills and attitudes of the Undergraduates This is attained through an array of activities such as organizing guest lectures, workshops and seminars on a wide range of topics with the collaboration of the industry; compilation and printing of course manuals; and assisting in the daily operations in the Accounting Resource Centre, Skills Development Centre, Accounting Mini Library, and the Music Centre. #### **SPORTS FIESTA 2013**

Sport Fiesta 2013 need no introduction to anyone who was in the University during October 2013. It was undoubtedly the most remarkable sports festival which had been held in the history of the University. The interdepartmental sports encounter was held on the 29th, 30th and 31st of October at the University grounds. The event was promoted through innovative series of posters, announcements during lectures and by a colourful and breadth taking flash mob. On the 29th, as a pre-event, a 5km road race was held. The fiesta started off with the games being officially declared opened by the Vice Chancellor of the University Lecturers and the AFMA Office Bearers, where the lecturers team led by Dean of the Faculty of Management Studies and Commerce, Professor Sampath Amrathunga, won. During the two days Athletic events, Swimming events and Team games (Cricket, Rugby, Football, Netball, Volleyball, Basketball, Carom, Chess and Table Tennis) were held. Approximately 1000 undergraduates took part representing the -twelve Departments of the Faculty and the first batch while over 2500 undergraduates were cheering for them.

The events continued on to the second day of the fiesta and the final marks added up to make the First Year Group A the champions and the Department of Business Administration, First Runners-Up. Athletic champions of the event were the First Year Group A and the Swimming champions, First year Group B. The closing ceremony was graced by the Finance Manager of Stretchline (Pvt) Ltd, Mr. Sujith Punchihewa, Head of the Department and other senior lecturers of the University.

#### CAREER FAIR 2013

Career Fair was organized by the AFMA with the initiative contribution of the internship committee, in collaboration with SLASSCOM and Career guidance unit of the University. It was held was on 25th of November 2013 in the Soratha Building Main Hall.

The main objective of the event was to provide undergraduates with an opportunity to find internship opportunities from the non- audit sector. The event was promoted through banners and lecture announcements and undergraduates were given the opportunity to register and handover their CVs to the committee two days prior to the event. Registration desks were set up near the entrance of the Soratha building and students were assigned numbers to be called for interviews. On the day of the event, presentations were done by the participating companies and thereafter interviews were held for the ones who had got themselves registered.

#### SUPAN BINDAK

Supan Bindak is the project of providing specialized water filtering systems, water tanks, fittings and awareness material to schools in the Anuradhapura district which are highly affected by chronic kidney disease due to high fluoride content in ground water and the farming community's exposure to inorganic pesticides and fertilizers.

This project was initiated by the special project committee but the total project would have not been realized if the health world giant "Nawaloka Hospitals PLC" had not backed us financially. The whole project was funded by the Nawaloka Hospitals PLC under their chain of charitable projects "Nawaloka Sathkara". Their mission of charitable activities is providing purified water sanitary facilities to the people in need, so under this theme they approved Supan Bindak and monitored the project until its success.

Within this project we could provide three filtering systems specially designed for the water samples taken from areas in which the schools to which they were donated were located. The filtering systems were developed by Lalanka Water Management Systems.

The project was held on 26th and 27th of November 2013 with the participation of Department students and lecturers. Filter installation and fixing of water tanks and other fittings were completed on 26th November with the initiation of technicians from Lalanka Water Management Systems, Department students, parents and teachers of those schools. The filter systems opening ceremonies were held parallel in 3 schools namely, Siddartha Primary School Medhawachchiya, Kona Kumbukgollawa Vidyalaya Medhawachchiya and Alapathwewa Vidyalaya Kebathigollawa, on 27th November. On that day thankful to Nawaloka Hospitals PLC, we could donate three filtering systems, 500ml water tanks, fittings, resins required for one year, and awareness material. On behalf of the Department we distributed some stationary to the school students.

With the end of the ceremony project faced its ultimate point of success by bringing a smile on to the lips of innocent poor people in the rural areas which are highly vulnerable to chronic kidney disease. With the completion of the project Nawaloka received heartfelt gratitude and honor of those innocent people.

#### NETHU PAHAN

Nethu Pahan is another CSR project organized as a result of needs identified during our pervious visit to Anuradhapura to donate water filters.

During our visit to Malsiripura to donate water filters last October, we were able to identify that students didn't possess sufficient stationery to pursue their educational activities. The main reason for it seemed to be the financial inability of their parents to afford such. In order to extend a helping hand to those under privileged children, we came up with project "Nethu Pahan", to donate such stationeries and other basic items such as lunch boxes, school bags and water bottles. For this purpose we chose eight primary schools from the Kebethigollewa and Padaviya areas and altogether there were 285 students. In addition to that a drawing competition among different grades was held and gifts were distributed and donations were also made to each school.

The project was funded through selling day cards designed and printed by one of our AFMA members, through sponsorships and donations from lecturers and undergraduates.

Another fact which made this project remarkable was the contribution given by the second year AFMA members in making this a success. It was a wonderful experience to work with them and create a strong bond among us.

The project was held on the 11th and 12th of October'14 where more than 60 undergraduates travelled to Kebethigollewa. On the date of the ceremony Head of the Department Dr. W.G.S Kelum and few other senior lecturers arrived at Kebetigollewa and together with us were able to bring a smile on to the lips of innocent school children.









#### New Year Ceremony 2014

Keeping with the traditions of the Department, a New Year ceremony was organized to embrace the dawn of year 2014. It was held at the Department building where all lecturers of the Department and AFMA members gathered. Celebrations commenced with the lighting of the traditional oil lamp followed by the boiling of milk in a clay pot placed on a hearth. The hearth was lit by the former Head of the Department, Ms. Samanthi Senaratne and the over flow of boiled milk from the pot was applauded by the gathering. Thereafter, pirith was chanted by clergy to in vogue religious blessings. Finally the crowd enjoyed a table of sweet meats.

The event was a great opportunity to unite as one family and to strengthen the bond between the lecturers and the undergraduates.





#### NANASA 2013

Nenasa is an annual project organized by the AFMA. As the name suggests the project is about inculcating knowledge to AL students in the rural districts of our country. Even though all of us in Sri Lanka are fortunate enough to benefit from a free education system, not all Government schools have equal opportunities and facilities. Only the National schools which have a direct funding from the Ministry of Education have facilities and a proper curriculum in place. The main problem faced by the minority under privileged schools is the shortage of skilled and competent teachers.

Nevertheless all students whether attending a National or a Provincial school have to face the same competitive G.C.E Advanced Level examination. So we as responsible citizens of this country considered it as our duty to extend a helping hand to those under privileged students.

This years' Nenasa seminar was held in Ampara. Students of schools in Ampara had gathered to Ampara D. S Senanayake College where the project was carried out. During the seminar, model question papers covering Economics and Accounting were discussed. The specialty of it was, the fact that the questions were prepared and the seminars were conducted by us. In addition few lecturers explained some important areas.





#### Alms Giving

The first event of the special project committee was to organize an alms giving for the priests in the Malsiripura Aranya. At the alms giving both breakfast and lunch were provided. The fund raising for the event was initiated by selling tickets and the contributions made by the lecturers and the students of the Department was appreciabe. This was not only our first event as the special project committee but it was also the first event for the AFMA during our tenure. Our members had one night stay and organized a successful event with the participation of the lecturers and all the second year students.

### NONIMI MEHEWARA



ACCOUNTANCY AND FINANCIAL MANAGEMENT ASSOCIATION NOTES TO THE FINANCIAL STATEMENTS FOR THE SEVENTEEN MONTH PERIOD ENDED 31ST OCTOBER 2014

#### 1. REPORTING ENTITY

#### 1.1 Legal Form

Accountancy and Financial Management Association (AFMA), is the student body of the Department of Accounting (DA) which was registered by complying with rules and regulations available for student associations of University of Sri Jayewardenepura.

# 1.2 Principal Activities and Nature of the Operations

Main objective is organizing activities to enhance the knowledge, skills and attitudes of the students in Department of Accounting (DA). Moreover the Association organizes projects which contribute to the development of national education and social wellbeing.

#### 2. BASIS OF PREPARATION 2.1 Basis of Measurement

The Financial Statements have been prepared on historical cost basis. Assets and liabilities are grouped by nature and in an order that reflect their relative liquidity. The Financial Statements have been prepared on the assumption that the Association will continue as a going concern for the foreseeable future. All Financial Statements are prepared on accrual basis except the Statement of Cash Flows.

#### 2.2 Functional and Presentation Currency

The Financial Statements of the Association is represented in Sri Lankan Rupees, which is the Association's functional currency. All financial information presented in Sri Lankan Rupees have been rounded to the nearest Rupee.

#### 2.3 Use of Estimates and Judgments

The preparation of the Financial Statements requires officers to make

judgments, estimates and assumptions for ongoing projects and future probable expenses. That affects reported amounts of assets, liabilities, income and expenses in near future. Actual results may differ from these estimates and those differences will be subsequently identified by next batch of AFMA officers.

Information about critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the Association's Financial Statements is included in the respective notes.

# 3. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these Financial Statements, unless otherwise indicated.

# STATEMENT OF FINACIAL POSITION

**3.1** Assets and Basis of their Valuation Assets classified as current assets on the Statement of Financial Position are cash and bank balances and those which are expected to be realized in cash during the normal operating cycle or within one year from the reporting date, whichever is shorter.

#### 3.2 Cash and Cash Equivalents

Cash and cash equivalents comprise cash at bank and cash in hand.

#### 3.3 Accumulated Fund

Accumulated fund represents the total equity of the Association as at the reporting date.

#### 3.4 Liabilities and Provisions

Liabilities classified as current liabilities on the Statement of Financial Position are those, which fall due for payment on demand or within one year from the reporting date.

Provisions are made to meet the expenses that would be incurred for the projects which have started and not finished at the time of reporting.

#### 3.5 Events after the Reporting Period

The materiality of the events after the reporting period has been considered and appropriate adjustments and disclosures have been made in the Financial Statements whenever necessary.

#### INCOME AND EXPENDITURE ACCOUNT 3.6 Income

#### Income is mainly generated through fund raising activities, donations and members' contributions. Income is recognized when persuasive evidence exists, that the benefits of those will be

recognized when persuasive evidence exists, that the benefits of those will be received to the Association and value can be measured reliably.

#### 3.7 Expenditure

All expenditure incurred for projects and maintaining the general administrative activities of the Association and have been charged against income in arriving at the Surplus/Deficit for the reporting period.

#### STATEMENT OF CASH FLOWS

The Statement of Cash Flows has been prepared using the "Direct Method" as specified in LKAS 07.

#### 3.8 Comparative Information

The comparative information is re-classified wherever necessary to confirm with the current year's presentation in order to provide a better presentation and rectification of errors.
